#### **BUSINESS REVIEW**

For the year ended 31 December 2019, the Group recorded total revenue of HK\$161,107,000, another significant increase of 102.5% year-on-year. Such increase was attributable to the increases in operating income of approximately HK\$55,310,000 and HK\$6,824,000 respectively from the growing financial leasing business and the newly developed big data business, as well as an increase of approximately HK\$13,278,000 in the income from disposal of development properties as a result of further sale of shopping mall units in block B of Shantou Commercial Plaza during the year.

In addition to the new profit contribution from the financial leasing business mentioned above, the Group recognised income of approximately HK\$78,819,000 from the reversal of payables for convertible notes which became due in 2007 but have exceeded the effective limitation period of prosecution, and increase in fair value of financial assets at fair value through profit or loss amounting to HK\$41,015,000. Moreover, the Group received other incomes totaling approximately HK\$74,288,000 including government subsidies for relevant projects in relation to its development of the industrial park in Danzao. After deducting financing costs including interest expenses incurred by the development of the industrial park in Danzao and other projects and investments, depreciation of land use right assets and other factors, the Group still posted net profit of approximately HK\$79,912,000 for the year, representing a significant increase of 43.2% year-on-year.

## 業務回顧

截至二零一九年十二月三十一日止年度,本集團總收入仍錄得約港幣161,107,000元,比去年同期大幅增加102.5%,主要由於融資租賃業務及大數據的新發展業務不斷開展,經營收入分別增加了約港幣55,310,000元及約港幣6,824,000元,而且今年成功進一步出售汕頭國商的B座商場單位,使出售發展物業收入增加了約港幣13.278,000元。

除了上述提及的融資租賃業務發展帶來了新增加的利潤貢獻外,由於2007年已到期的可換股票據之應付款項已經超過有效訴訟追訴期,故本集團進行回撥,取得回撥收益約港幣78,819,000元以及按公允值入損益之金融資產之公允值增加到約港幣41,015,000元,此外,本集團因發展丹灶產業園而取得了有關項目的政府補貼等其他收入合共約港幣74,288,000元,即使扣除了為丹灶產業園等項目及投資所衍生的利息支出等融資成本、土地使用權資產之折舊及綜合其他因素後本集團全年仍然錄得淨利潤約港幣79,912,000元,比去年大幅增加了43.2%。

#### FINANCIAL LEASING BUSINESS

In view of the increasing economic penetration of financial leasing driven by its growing demand from sustainable growth in China's economy and diversified financing models, the Group remains positive on the outlook of financial leasing sector in China based on rational risk management, despite the pressure from heightened bad debt risks amid the economic impact from the Sino-US trade tensions. Against this backdrop, the Group has been engaged in the operation and management of financial leasing business and gradually accumulated experience through Guangdong Financial Leasing Co., Ltd.\*(廣東粵科融資租賃有限公司), a 25%-owned associate of the Group, and established a wholly-owned subsidiary Canton Risen Financial Leasing Co., Ltd.\*(廣東粵盛科融資租 賃有限公司) to further develop related business, which initially intends to focus on business areas including public utilities, environmental protection and energy conservation, new energy and telecommunication projects. Thanks to its rapid growth during the year, the seament recorded operating income of approximately HK\$80,531,000, representing a significant increase of 2.2 times year-on-year with operating profit of approximately HK\$35,457,000, which is expected to fuel the Group's future earnings growth.

Furthermore, given the COVID-19 outbreak in early 2020 (the "coronavirus outbreak"), the Group carried out a series of inspections on its financial leasing customers to understand and track the fallout on delayed production resumption, product sales and collection of receivables, in a bid to mitigate adverse impact of the epidemic on relevant asset quality. Based on our current elevation, we believe that the existing customers are able to draw upon their sound fundamentals including stable cash flows, an indicator to resilience against the epidemic once it becomes under control, to survive the challenges with our aid at present. In this regard, the Group sees a sound picture of asset quality, and will keep a close eye on the assets under a well-established emergency response plan.

## 融資租賃業務

隨著中國經濟的持續發展及增長,融資模式多 樣化,對融資租賃的需求將不斷加大,融資租 賃行業對經濟的滲透勢必不斷增強,即使在 中美貿易戰陰霾下,中國經濟被受影響,中國 融資租賃行業將面臨壞賬風險上升的壓力, 本集團認為中國融資租賃行業能夠做好風險 管理工作,發展前景仍然相當樂觀。因此,本 集團已透過所持有25%權益之聯營公司廣東 粵科融資租賃有限公司從事營運及管理融資 租賃業務及逐步累積相關經驗,並且成立了 全資附屬公司廣東粵盛科融資租賃有限公司 以進一步拓展相關業務,初步擬專注於公用 事業項目、環保及節能項目、新能源項目以及 電訊項目等業務方向,今年已不斷迅速發展, 錄得營業收入約港幣80,531,000元,較去年同 期分別大幅上升2.2倍,並已經取得經營利潤 約港幣35.457.000元,預計可提升本集團的未 來盈利增長。

此外,鑑於二零二零年初新型冠狀病毒疫情爆發(「疫情爆發」),對融資租賃客戶進行了一系列的排查,就客戶因疫情延誤復工復產、產品銷售及資金回籠所受到的影響情況進行瞭解和跟蹤,盡力化解本次疫情對有關資產質量的不良反應。經評估後認為現有客戶的基本面相對比較好,有穩定的現金流,初步判斷在疫情控制後,客戶自我修復能力較強,客戶館該能度過難關。因此,總體的資產質量還是較好的,但仍會密切監察及制定相應的應急預案。

#### PROPERTY INVESTMENTS

The Group's overall rental income in 2019 was approximately HK\$9,879,000, representing an increase of 45.7% year-on-year. As the ancillary facilities at China Holdings Building in Foshan and its surroundings were increasingly mature, the overall occupancy rate of China Holdings Building increased to approximately 90% and the rental income for the year amounted to approximately HK\$8,143,000, representing a significant increase of 71.22% year-on-year. As a majority of the properties of Shantou Commercial Plaza were sold out last year, its rental income for the year decreased year-on-year by 26.61% to approximately HK\$1,023,000. Huizhou International Commerce Building registered no rental income for the year as all its remaining properties were sold out early last year. As for the properties in Hong Kong sales, the rental income increased by 15.75% year-on-year to HK\$713,000 for the year, as a result of higher rent rate after the lease renewal.

In respect of property sales, the Group successfully completed the disposal of shopping mall units in block B of Shantou Commercial Plaza, cashing out a total of approximately HK\$30,378,000. It posted a slight loss of approximately HK\$524,000 from disposal of development properties for the year, as the disposal was made at a consideration slightly lower than book value.

With its solid position in the property development and investment sector and by capitalizing on experience in such fields, the Group established Guangdong Sino Rock Tyco Construction Co., Ltd.\* (廣東中岩泰科建設有限公司) ("Sino Rock Tyco"), a 72%-owned joint venture of the Group, to develop the industrial park in Danzao Town, Nanhai District, Foshan City, the PRC, which is designed to house the main and spare production plants, pilot base, research and development center and ancillary facilities for new energy vehicles. In the first half of the year, we completed leasing the land right of approximately 1,400 Chinese acres for industrial park use. and commenced the site levelling. Subsequently, we will implement construction stage by stage depending on the actual situation. Meanwhile, we completed our plan on the acquisition of the Danzao Xianhuwan property, which was expected to be reconstructed into a research and development center and ancillary facilities for the park. We completed reconstruction of the exhibition hall in October 2019. while for other parts, reconstruction and fitting-out design were completed and the construction process will be started soon. The primary construction work for the industrial park is expected to be completed in 2020.

## 物業投資

本集團二零一九年整體投資物業租金收入為約港幣9,879,000元,比去年同期增加45.7%,其中,由於佛山中控大廈配套設施及週邊環境漸趨成熟,中控大廈整體出租率上升至約90%,租金收入為約港幣8,143,000元,較去年大幅上升71.22%。而汕頭國際商業大廈由於大部份物業已於去年售出,使租金收入比去年同期下降26.61%至約港幣1,023,000元。惠州國商大廈剩餘物業亦已於去年初全比去年同期下降26.61%至約港幣1,023,000元。惠州國商大廈剩餘物業亦已於去年初全部售出,導致惠州國商大廈今年已經沒有租金收入。至於香港物業,由於續訂租約後上調租金、較去年同期上升了15.75%,期內租金收入為港幣713,000元。

物業出售方面,本集團今年成功進一步出售汕頭國商的B座商場單位共套現約港幣30,378,000元,但由於以稍微低於賬面值出售套現,導致今年出售發展物業產生輕微虧損約港幣524,000元。

憑藉本集團於物業發展及投資板塊之深厚根 基,借助於該等領域所累積之經驗,成立附屬 合資公司廣東中岩泰科建設有限公司(「中岩 泰科」)(本集團持有72%股權)致力發展位於 中國佛山市南海區丹灶鎮之產業園,其將包 括新能源汽車的主要及備用生產廠房、中試 基地、研發中心及配套設施等等,今年上半年 已經完成了約1,400畝產業園區的土地使用權 租賃工作,並開始進行場地平整工程,建設工 程將按實際情況相繼分階段展開;與此同時, 完成了收購丹灶仙湖灣物業計劃將其改造為 產業園之研發中心及其他配套設施,並已於 2019年10月完成了當中展館部份之相關改造 工程,其餘改造工程的裝修改造設計等工作 亦已完成,將積極落實有關施工進行,預期產 業園的主要建設將於二零二零年內竣工。

After the reporting period, the coronavirus outbreak in early 2020 might weigh on and bring down the Group's rental income amid potentially depressed economic sentiment. In addition, labor shortage due to the delayed production resumption as a result of epidemic control should affect the development and construction paces of our industrial park project in Danzao Town, leading to a potential delay in its completion schedule. Meanwhile, the epidemic may also drag down economic environment, thus mounting pressure to the industrial park in lease solicitation. The Group will make every effort in epidemic control, and take countermeasures to minimize its impact on operation and construction.

報告期後,二零二零年初疫情爆發,預期經濟氣氛呈下降趨勢,對本集團租金收入或會造成影響及減少。此外,因疫情延誤復工復產,影響勞動力下降,對丹灶鎮產業園項目開發建設進度造成影響,可能會導致竣工時間延遲;同時,疫情亦會影響經濟環境,對未來產業園招商招租構成一定壓力。本集團將盡力做好疫情防控工作,並積極採取相關應對措施,盡可能減小疫情對經營和建設的影響。

#### **WELLNESS ELDERLY CARE BUSINESS**

With the experience in building a smart platform for the management of integrated elderly care services in Nanhai District (the "Smart Elderly Care Services Platform"), Guangdong Yibaijian Comprehensive Health Technology Ltd.\*(廣東壹佰健大健康科技有限 公司) ("Yibaijian"), a 100%-owned subsidiary of the Group, planned to gradually expand the exemplary Smart Elderly Care Services Platform to other towns in Nanhai District, aiming to develop platform in the surrounding areas of Foshan and even within and outside Guangdong Province. During the year, we proactively promoted the development of the Smart Elderly Care Services Platform in Shuangyashan, Heilongjiang, and helped Shuangyashan Civil Affairs Administration to complete inspecting the platform, which laid a solid foundation for the initiative of "walking out of Nanhai and facilitating surrounding areas". On 26 November 2019, the platform in Shuangyashan passed initial examination. Besides, the Group will further optimize the Smart Elderly Care Services Platform and ensure more efficient management with IT-based approaches. In addition, the Group will explore various value-added services for health management, such as referral and quality supervision of home elderly care services and relief, to diversify sources of operating income. The segment recorded operating income of approximately HK\$7,877,000, representing an increase of 78.8% year-on-year, and turned profitable with insignificant operating profit of approximately HK\$1,088,000 contributed to the Group.

## 大健康養老業務

廣東壹佰健大健康科技有限公司(「壹佰健」) (本集團持有100%股權)憑藉過往南海區智 慧養老綜合服務管理平台(「智慧養老服務平 台」)的建設經驗,通過南海平台的示範帶動 作用,計劃逐步推展至南海區內外其他市鎮, 進行佛山周邊、省內及省外的養老平台項目 的開拓,今年積極推動智慧養老服務平台建 設項目落戶黑龍江雙鴨山市,並協助雙鴨山 市民政完成對智慧養老服務平台考察工作, 為「走出南海,輻射周邊」的計劃目標邁出了 堅實的一步,並已於2019年11月26日完成雙 鴨山平台項目初驗工作。同時本集團將進一 步優化智慧養老服務平台,更好實現平台的 資訊化管理水準,並開拓各種健康管理的增 值服務,包括家居養老服務與救助的轉介及 質量監督等等,以增加經營收入渠道。今年錄 得營業收入約港幣7,877,000元,比去年增加 了78.8%, 為本集團提供輕微經營利潤約港幣 1,088,000元, 扭虧為盈。

At the same time, in accordance with the "Nanhai District Inclusive Elderly Care Service System" approved by the Nanhai District Government of Foshan City, the Group accelerated the restructuring and management transfer of the Nanhai District Social Welfare Center. In the first half of the year, we established a wholly-owned subsidiary Guangdong Taoyuan Comprehensive Health Operation Co., Ltd.\*(廣東桃苑大健康產業運營有限公司)for investment, construction and operation of elderly care service system throughout the district. The Group also cooperated with Jiujiang Town to launch the first town-level elderly care service project in Nanhai District to manage investment and operation of Jiujiang Taoyuan Nursing Home\*(九江桃苑頤養院). Despite numerous difficulties. Jiujiang Taoyuan Nursing Home was completed in an efficient manner, commenced operation on 26 June 2019 and began to offer quality service for elderly people from 1 July 2019. However, as no income was generated at the initial investment stage, it recorded an operating loss of approximately HK\$4,139,000.

After the coronavirus outbreak in early 2020, we stepped up our epidemic control efforts to minimize safety risk to the epidemic. In particular, various epidemic control measures were launched according to actual situation at Jiujiang Taoyuan Nursing Home, to ensure quality elderly care services for elderly people, a high-risk vulnerable group susceptible to the epidemic.

二零二零年初疫情爆發後,為了降低疫情的 安全風險,加強各項疫情防控工作,尤其九江 桃苑頤養院內老年人屬於疫情易感染人群和 高危易發病人群,將根據疫情實際情況推進 做好各項防疫工作,確保優質養老服務。

#### **BIG DATA BUSINESS**

In February of last year, the Group established a wholly-owned subsidiary Guangdong Sinsing Technology Ltd.\*(廣東鑫興科技 有限公司) to engage in industrial Internet project construction, smart city construction, big data operation and management and other businesses. Remarkable results were achieved in the year, as evidenced by the independent research and development of Industrial Internet Identification Public Service Platform. Equipped with SSL server credentials, the platform is able to provide identification application enterprises with reliable identification registration and resolution services, product tracing and demonstration, to facilitate business promotion and expand the scope of business. Besides, the proprietary Smart Elderly Care Services Platform co-developed with our fellow subsidiary Yibaijian owns independent technical capability, enabling us to independently develop other projects without relying on other technological service providers and hence laying a solid foundation for growth upon our enhanced technical research and development capability. Also, we were recognised by the industry with the 2018 Outstanding Contribution Award from the Alliance of Industrial Internet. The segment recorded operating income of approximately HK\$18,881,000, representing an increase of 56.6% year-on-year, with insignificant net profit of approximately HK\$29,000.

#### **HOTEL BUSINESS**

Guilin Plaza ("Guilin Plaza") stepped up promotion to exhibition customers, marketing through online platforms and offline marketing focusing on overseas tourist groups, tapped into new markets for more customers, and made the system more sensitive to market fluctuations and more quick and flexible for pricing adjustment. We took initiative to develop value-added services based on hardware with a view to maximizing operating income, seeking to expand the business portfolio. The average occupancy rate improved by 2.89% year-on-year, reaching 59.81%. Despite a 2.13% drop in average room rate, the operating income increased by 2.2% year-on-year to approximately HK\$13,519,000, and the operating loss narrowed by 8.5% year-on-year to HK\$5,504,000.

## 大數據業務

本集團於去年2月份成立了全資附屬公司廣 東鑫興科技有限公司從事工業互聯網項目建 設、智慧城市建設、大數據運營管理等業務, 今年已取得相當成果,自主研發了工業互聯網 標識公共服務平台,該平台已配置SSL伺服器 憑證,可為標識應用企業提供安全的標識註 冊和解析服務、產品溯源資訊查詢與展示等 服務,有助項目的業務推廣,並且不斷擴大業 務範圍;同時,與系內壹佰健合作自主研發智 慧養老服務平台,確立平台的自主獨立技術 能力,無需依賴其他科技公司,亦開展多個其 他自主研發項目,不斷提升公司技術研發能 力,為發展奠定堅實的基礎;此外,更取得行 業認可,榮獲工業互聯網產業聯盟頒發2018 年突出貢獻獎。今年營業收入提升了56.6%, 錄得約港幣18,881,000元,而且出現了輕微淨 利潤約港幣29.000元。

## 酒店業務

桂林觀光酒店(「觀光酒店」)積極加大會議客戶的促銷力度、網路平台線上行銷與重點開發境外團隊客源的線下行銷力度,積極開拓新的客源市場,增強對市場變化感知的敏鋭性以及價格調控的及時性、靈活性,並在硬體上積極開發增值服務項目,實現經營收益最大化的總體經營思路,大力拓展經營業務,平均住房率較去年改善了2.89%,達到59.81%,即使平均房價有所下降約2.13%,營業收入仍比去年增加了2.2%至約港幣13,519,000元,今年經營虧損比去年收窄了8.5%至約港幣5,504,000元。

After the reporting period, China's tourism industry suffered from the coronavirus outbreak in early 2020, particularly the city-wide quarantine policy, travel restrictions adopted by a number of cities in China, and public concerns about the epidemic. As a result, guest room marketing of Guilin Plaza was suspended until late March 2020. Even if the hotel reopens, the Group is not optimistic about its income in 2020.

In order to diversify businesses related to hotel operations, the Group established China Select Small Hotel Union Limited, a 51%-owned subsidiary of the Group, with T-Box Union (China) Financial Holdings Investments Limited and T-Box Union Investments Limited, in an effort to provide integrated service in the homestay inn and small hotel industry, including the provision of quickly-constructed T-BOX® mobile homes with zero-sewage discharge environmental-friendly systems, direct sale management software and financing solutions. Based on the future-oriented interdependent business model and with the dawn of the 5G era, the year witnessed the establishment of Duoduo Meisu\* (多多美宿直賣), a domestically leading direct sale platform for scenic homestay inns, with the online market promotion and brand awareness work under way. As the business was still in initial promotion, it posted an operating loss of approximately HK\$1,506,000, narrowing by 58.6% year-on-year.

報告期後,二零二零年初疫情爆發,隨著「封城」政策之實施、中國若干城市施加出行限制,以及大眾面對疫情爆發之情緒所影響,已經對中國旅遊業造成衝擊。觀光酒店之客房銷售業務因而暫停至二零二零年三月下旬,即使恢復營業,二零二零年旅遊業的收入並不容樂觀。

為拓展酒店相關多元化業務,本集團與盒盟(中國)金融集團投資控股有限公司和盒盟投資有限公司組建興業民宿互助社有限公司(本集團持有51%股權)以致力為民宿及小而美酒店行業提供綜合服務,包括提供快速組建並配備零污水排放環保系統的T-BOX移動房屋、直銷管理軟件及融資解決方案。基於面向來的互助共生的商業模式,在5G時代到風景、大背景下,今年已積極打造國內領先的風景、民宿直賣平台一多多美宿直賣,籌備線上市的大背景下,提升品牌認知。但是由於業務尚在初步推廣階段,因而出現了經營虧損約港幣1,506,000元,對比去年收窄了58.6%。

#### PROFIT FROM INVESTMENTS IN ASSOCIATES

Nanhai Changhai Power Company Limited\* (南海長海發電有限公司) ("Changhai Power"), a 31.875%-owned joint venture of the Group, recorded a cost reduction due to the lower coal prices in the year, which improved the operating performance with an operating profit of approximately HK\$229,700,000, thus contributing earnings of approximately HK\$73,564,000 to the Group, representing an increase of 16.46% year-on-year.

#### 聯營公司投資收益

由於南海長海發電有限公司(「長海發電」) (本集團持有31.875%股權)由於期內煤價下 跌而降低了成本,使經營業績有所提升,錄 得經營利潤港幣229,700,000元,為本集團提 供盈利貢獻港幣73,564,000元,比去年增加 16.46%。

As Guangdong Financial Leasing Co., Ltd.\*(廣東粵科融資租賃有限公司), a 25%-owned associate of the Group, faced the problem of bad debts in this year and substantial reduction in revenue and operating profit, the Group made a decision on disposal and entered into an agreement on asset sale on 30 September 2019. The transaction is still processing due to the coronavirus outbreak and the Group received the partial consideration in January 2020. For the period ended 31 October 2019, Guangdong Financial Leasing Co., Ltd. recorded operating profit of approximately HK\$26,250,000, and contributed earnings of approximately HK\$6,562,000 to the Group.

由於廣東粵科融資租賃有限公司(本集團持有25%權益)今年面對壞賬問題,以及業務收入大幅收縮,導致經營利潤大幅下跌,於二零一九年九月三十日本集團決定出售及簽訂了有關出售協議。因疫情爆發,此交易尚在處理當中,本集團已於二零二零年一月收取部份代價。截至二零一九年十月三十一日,廣東粵科融資租賃有限公司之經營利潤約港幣26,250,000元,為本集團提供盈利收益港幣6,562,000元。

On 20 August 2018, Foshan City Nanhai Canmanage Investments Holdings Limited\* (佛山市南海康美投資有限公司) ("Nanhai Canmanage"), a wholly-owned subsidiary of the Group, completed its investment in 49% of Guangdong Tiannuo Civil Explosives Co., Ltd.\* (廣東天諾民爆有限公司) ("Tiannuo"), and on 9 October 2018, Tiannuo completed the acquisition of Guangdong Nanhong Chemical Co., Ltd.\* (廣東南虹化工有限公司) ("Guangdong Nanhong"). The transactions allow the Group to improve its profitability and explore the potential of the domestic civil explosive business. Due to the impact on its business results from a technological modification project in the year, Tiannuo only recorded a profit of approximately HK\$8,627,000 for the year after depreciation adjustment for fair value of the assets acquired, and contributed earnings of approximately HK\$4,228,000 to the Group.

於二零一八年八月二十日,本集團之全資附屬公司佛山市南海康美投資有限公司(「南海康美」)完成了入股廣東天諾民爆有限公司(「天諾民爆」)49%股權,以及天諾民爆亦已於二零一八年十月九日完成收購廣東南虹化工有限公司(「廣東南虹」),有助提升本集團的盈利能力及開拓國內民爆業務,但由於天諾民爆今年需要進行技改工程,對業績造成了影響,導致今年經收購資產公允價折舊調整後利潤僅錄得約港幣8,627,000元,為本集團提供盈利收益約港幣4,228,000元。

After the reporting period, some workers were unable to return to work as scheduled, mainly due to the coronavirus outbreak in early 2020, delayed production resumption after the Lunar New Year holidays, suspended or limited transportation in certain domestic cities, and the 14-day quarantine requirement on workers who left from other "high-risk" provinces before permitted to return to work. As a result, Changhai Power was weighed on by weaker demand, as some customers of its power supply and steam heating business have yet to resume normal operations, which is expected to affect its business results in 2020. Also, Tiannuo needs to postpone its resumption of operations till 27 February 2020, which may have an impact on its business results in 2020.

此外,期後二零二零年初疫情爆發,綜合農曆新年假期後延遲復工、中國若干城市交通運輸暫停或僅提供有限度服務,加上由中國其他「高風險」省份出境之工人在准予復工前實施14天檢疫隔離規定等因素影響,有若干工人無法如期返回工作崗位。因此,長海發電及加索下降而受到拖累,此乃由於受其供電及加熱蒸汽之部份客戶尚未恢復正常業務營運,預計二零二零年業績會有所影響。與此同時,天諾民爆亦需要推遲至二零二零年二月二十七日才恢復業務營運,對其二零二零年業績也有一定影響。

#### FINANCIAL POSITION AND ANALYSIS

As at 31 December 2019, the Group had total assets of HK\$5,147,666,000 (31 December 2018: HK\$3,460,537,000), total liabilities of HK\$3,441,696,000 (31 December 2018: HK\$2,129,217,000), a gearing ratio (being total liabilities divided by total assets) of 66.9% (31 December 2018: 61.5%), net assets of HK\$1,705,970,000 (31 December 2018: HK\$1,331,320,000), and equity attributable to owners of the Company per share of HK64.54 cents (31 December 2018: HK58.00 cents).

The Group had net current assets of HK\$505,514,000 (31 December 2018: HK\$212,713,000), a current ratio (being current assets divided by the current liabilities) approximately 1.36 times (31 December 2018: 1.15 times) and the bank balance and cash of HK\$1,028,396,000 (31 December 2018: HK\$1,221,671,000), which are sufficient for capital requirements for future operation and new projects or business development of the Group.

## **PLEDGE OF ASSETS**

As at 31 December 2019, properties of the Group for own use and investment, bank deposits, entity interest of a subsidiary and finance lease receivables with a carrying value of approximately HK\$1,906,513,000 were pledged to banks as the security for the bank borrowings granted to the Group (31 December 2018: properties of the Group for own use and investment, bank deposits and finance lease receivables with a carrying value of approximately HK\$899,816,000 were pledged to banks).

## 財務狀況及分析

截至二零一九年十二月三十一日止,本集團之總資產為港幣5,147,666,000元(二零一八年十二月三十一日:港幣3,460,537,000元),總負債為港幣3,441,696,000元(二零一八年十二月三十一日:港幣2,129,217,000元),資產負債比率(即總負債除總資產)為66.9%(二零一八年十二月三十一日:港幣1,331,320,000元),本公司擁有人應佔權益每股為港幣64.54仙(二零一八年十二月三十一日:港幣58.00仙)。

本集團之淨流動資產為港幣505,514,000元(二零一八年十二月三十一日:港幣212,713,000元),流動比率(即流動資產除流動負債)約為1.36倍(二零一八年十二月三十一日:1.15倍),而銀行存款及現金則為港幣1,028,396,000元,(二零一八年十二月三十一日:港幣1,221,671,000元),足以應付本集團的未來營運及新項目或業務發展之資金需求。

## 資產抵押

於二零一九年十二月三十一日,本集團之自用及投資物業、銀行存款、本集團所持有的一間子公司之實體權益與融資租賃應收之賬面值約港幣1,906,513,000元已抵押予銀行,作為本集團獲銀行借款之抵押品。(二零一八年十二月三十一日:本集團之自用及投資物業、銀行存款與融資租賃應收之賬面值約港幣899,816,000元已抵押予銀行)。

#### FOREIGN EXCHANGE EXPOSURE

The Group's main operating income and costs are denominated in RMB. In the business operation of the Group, foreign exchange fluctuation of income and costs would be mutually offset. However, as the Hong Kong-based Group has injected a substantial amount of current borrowings into domestic wholly-owned subsidiaries in Mainland China and held a huge amount of monetary assets denominated in RMB, an exchange gain or loss would generate from the appreciation or depreciation of RMB. It is expected that an increase or a decrease of approximately HK\$8,126,000 in the Group's profit for the year would be resulted if the exchange rate of RMB to HKD appreciates or depreciates by 5%. Over the few past years, RMB constantly showed an upward trend and gradually became stable in the second half of 2008. Nevertheless, RMB started to fluctuate upward and downward repeatedly in recent years. With the Sino-US trade war occurred last year, the exchange rate of RMB against USD dropped sharply, and has gradually become balanced and fluctuated in both directions in the first half of the year. However, the Sino-US trade war intensified abruptly in August 2019, resulting a remarkable drop in exchange rate of RMB against USD and an exchange loss of approximately HK\$5,194,000 incurred by the Group. The Board believes that RMB will be immensely affected by any change in the Sino-US trade war in the short term. A turnaround in the Sino-US trade war may lead to a rapid rebound, therefore the trend of RMB is unforeseeable in the short term. Though in the long run, it is expected that RMB will become stable and will not expose the Group under significant and long term adverse foreign exchange risk. Accordingly, it is not necessary for the Group to hedge against foreign exchange risk at the moment.

## 外匯風險

本集團主要賺取人民幣並承擔以人民幣計算 的成本,在本集團的業務營運中對收入與成本 的匯率波動影響會相互衝減。不過,本集團以 香港為基地對國內全資附屬公司投放了大量 往來借款,同時本集團亦擁有大量人民幣貨幣 資產,導致因人民幣升值或降值而帶來匯兑 收益或虧損,預計人民幣兑港幣升值或貶值 5%,則會影響本年度盈利增加或遞減約港幣 8.126,000元。綜觀過去歷年以來,人民幣均 呈現上升趨勢,直至二零零八年下半年升勢 才漸趨平穩,而近年人民幣開始反覆雙向波 動,但去年中出現中美貿易戰爭,影響人民幣 兑美元急速下跌,今年上半年漸漸趨於平衡 及雙向波動,不過,2019年8月中中美貿易戰 又突然惡化,導致人民幣兑美元大幅下跌,導 致集團錄得匯兑損失約港幣5,194,000元,故 董事會認為人民幣短期內仍會深受中美貿易 戰爭之變化影響,若中美貿易戰爭出現轉機, 更可能急速反彈,故短期內難以預料,然而就 長期而言,人民幣將會持續平穩,不會對本集 團長期構成重大不利外匯風險。因此,本集團 暫沒有任何為外匯風險作出對沖的需要。

## **OUTLOOK**

With experience accumulated during the course of transformation and upgrade over past years, the Group has generally set its focus and direction for development. To seize opportunities of market development, the Group will strive to adjust and optimize its businesses, shifting to segments such as industrial parks/property development and investment, financial service, technology and wellness elderly care. In respect of the property development and investment, with our solid position in the property development and investment sector and by capitalizing on experience in such fields, the Group will continue to develop the new energy industrial park in Danzao Town, Nanhai District, Foshan City, China. In respect of the financial service sector, drawing upon the increasing demand for finance lease amid China's economic growth and changes in financing models and in view of the fallout of the Sino-US trade war and the coronavirus outbreak, the Group will further develop the financial leasing business and intends to focus on business areas including public utilities, energy conservation and environmental protection, new energy and telecommunication projects, while being cautious to risk management. In respect of the technology sector, by taking advantages of the opportunities arising from the new smart city construction plan in Nanhai District, the Group will continue its research and development efforts in the Big Data industry projects on an independent basis, as a main driver to our profit growth in the future. In the wellness elderly care sector, based on the Smart Elderly Care Services Platform, the Group will expand to cover other wellness elderly care services. After establishing the first institutional elderly care project in the first half of the year, the Group will continue to head in the direction of institutional elderly care business and the development of a 3-tier elderly care system comprising institutes, communities and households in Nanhai District. Meanwhile, the Group will, through its joint ventures and associates, participate and invest in power generation, civil explosives, and other high-growth industries in the PRC. With the aforesaid business development directions, the Group will be able to expand its business and gradually achieve the goal of increasing and maintaining stable returns for shareholders.

## 展望

本集團總結過去數年轉型升級過程中所吸取 的經驗,基本確定了本集團發展重點及方向。 本集團將積極把握市場發展機遇,致力調整 及優化集團業務,朝產業園/物業發展及投 資、金融、科技、大健康養老板塊發展。在物 業發展及投資方面,憑藉本集團於過往物業 發展及投資板塊之深厚根基,將繼續借助其 於該等領域累積之經驗,致力發展位於中國 佛山市南海區丹灶鎮之新能源產業園。在金 融板塊方面,隨著中國經濟增長及融資模式 變化,對融資租賃的需求持續增大,但在中美 貿易戰陰霾及疫情爆發影響下,本集團將努 力做好風險管理工作下,進一步拓展融資租 賃業務, 擬專注於政府公用事業項目、環保及 節能項目、新能源項目以及電訊項目等業務 方向;在科技板塊方面,藉著南海區新型智慧 城市建設計劃的契機,將持續積極調研發展 大數據產業項目,在自主研發的基礎上積極 發展,作為帶動未來集團利潤增長的一項主 要來源;大健康養老板塊方面,在智慧養老服 務平台的基礎上,將進一步伸延至其他大健 康養老服務範疇,並於今年上半年實現了第 一個機構養老項目,本集團將持續朝機構養 老業務方向邁進,繼續向構建南海區機構、社 區及居家三級養老體系方向發展;同時本集 團亦透過其合營企業及聯營公司參與及投資 包括發電、民用爆炸品以及其他中國高增長 行業。通過以上各業務發展方向,不斷擴大本 集團業務領域,逐步實現提升及維持穩定股 東回報的目標。

The Board is principally responsible for establishing the development direction of the Group, formulating targets and business development plans, approving major agreements and matters, monitoring the performance of senior management and is responsible for corporate governance with a view to increasing shareholders' value. Led by the managing director, the management is responsible for implementing the strategies and plans developed by the Board. The Board authorizes the management to manage the day-to-day business operations of the Group. Each committee under the Board has its own specified terms of reference which clearly define their powers and responsibilities.

The Board convenes at least four regular meetings each year (approximately once each quarter) and will convene meetings when necessary. When a regular board meeting is convened, the Board papers will be sent to directors for review before the meeting pursuant to the deadline as required by the Listing Rules and the code provisions so that directors can keep abreast of the information to perform their duties and responsibilities.

The Board has adopted a dividend policy (the "Dividend Policy") which does not have any pre-determined dividend payout ratio. In considering dividend payment, the Board will take into account factors such as the Group's expected financial performance, business conditions and strategies, expected working capital requirements and future expansion plans, business cycles and other internal or external factors that may affect the Company's business or financial performance and financial position, return and interest of the shareholders and other factors which the Board considers to be relevant. The Board will review the Dividend Policy from time to time and the Dividend Policy does not constitute any commitment or obligation of the Company to declare dividends.

# ROLES AND DUTIES OF CHAIRMAN AND MANAGING DIRECTOR

The chairman and the managing director have different roles. The chairman is responsible for the operation of the Board and the managing director is responsible for managing the operations of the Group. Their functions have been clearly divided to ensure a balanced distribution of power and authority so that they will not concentrate on a single individual.

The chairman of the Board is Mr. He Xiangming and the managing director of the Company is Mr. Lin Pingwu. The deputy managing directors of the Company are Mr. Huang Zhihe and Ms. Wang Xin.

The chairman of the Board is principally responsible for leading the Board and ensures the Board acts in the best interests of the Company. The chairman shall ensure the Board operates effectively and performs its proper duties and discusses all important and proper matters in a timely manner. The chairman is responsible for convening board meetings, consulting, determining and approving the agenda of each board meeting, and ensuring that directors are provided sufficient information on current matters in a timely manner. The chairman is also responsible for ensuring that the Company formulates good corporate governance practice and procedure.

The managing director is principally responsible for the daily operation and management of the Group's overall operations and implementing the Board's operating strategy and policy and delegating tasks to all departments for implementation so as to realize the Board's objectives and decisions. In addition, the managing director is also responsible for coordinating close cooperation among all departments, uniting efforts of staff and encouraging the initiative of staff so as to ensure smooth and effective operation of the Company's operations and systems.

All newly appointed directors are provided with necessary induction and information to ensure that he has a proper understanding of the Company's operations and businesses as well as his responsibilities under the relevant statutes, laws, rules and regulations. The Company Secretary and representative of auditor update directors on the latest development and changes regarding the Listing Rules, accounting standards and other relevant regulatory requirements from time to time.

In addition, the directors are provided with monthly updates on the Company's performance and position to enable the Board as a whole and each director to discharge their duties.

All directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. According to the records provided by the directors, all directors have participated in continuous professional development for the year ended 31 December 2019.

During the year under review, all directors of the Company participated in continuous professional development to update their knowledge and skills by reading materials relevant to the directors' duties and responsibilities and/or their relevant professional and by attending the training programs arranged by the Company. In addition, Mr. Chan Kwok Wai also had attended talks and seminars organised by different professional institutions in relation to the knowledge of the Listing Rules and directors' responsibility etc.

#### SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers ("the Model Code") set out in Appendix 10 to the Listing Rules as the code of conduct regarding securities transactions by directors. After making specific enquiries, all directors have confirmed that, in respect of the year ended 31 December 2019, they have complied with the required standard as set out in the Model Code.

Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

Risk mitigation plans and risk owners are then established for those risks considered to be significant.

The Board considers the Group's risk management and internal control systems are effective.

# Procedures and internal controls for the handling and dissemination of inside information

The Company has adopted a policy on disclosure of inside information which sets out the obligations, guidelines and procedures for handling and dissemination of inside information. The Group discloses inside information to the public as soon as reasonably practicable unless the information falls within any of the Safe Harbours as provided in the Securities Future Ordinance. The Group ensures the information is kept strictly confidential before the information is fully disclosed to the public, if the Group believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, the Group would immediately disclose the information to the public. The Group is committed to ensure that information contained in announcements are not false or misleading, or false or misleading through omission of a material fact in view of presenting information in a clear and balanced way, which requires equal disclosure of both positive and negative facts.

#### COMMUNICATION WITH SHAREHOLDERS

The Company understands the importance of good communication with shareholders and investors, and recognizes the value of providing current and relevant information to shareholders and investors. The Board has established a shareholders' communication policy setting out the principles of the Company in relation to shareholders' communication, with the objective of ensuring that both shareholders and investors can obtain the complete, identical and current information of the Company in a timely manner.

The Company has maintained communication with shareholders through the annual general meeting or other general meetings and encourages them to participate in general meetings. Registered shareholders receive notices of general meetings by post. The notice of general meeting contains the agenda, the proposed resolutions and the voting form. Any registered shareholder is entitled to attend the annual general meeting and special general meetings provided that their shares must be registered in the register of members. Shareholders who are unable to attend the general meeting can fill in the proxy form attached with the notice of general meeting and return the same to the Company so as to appoint their representatives or the chairman of the meeting as their proxies.

At the annual general meeting held on 23 May 2019, the first special general meeting of 2019 held on 23 May 2019, the second special general meeting of 2019 held on 23 May 2019, all directors were present to answer questions raised by shareholders and separate resolution in respect of each separate issue was proposed for shareholders to vote thereon. The Company appointed branch share registrar of the Company to act as scrutineers and to ensure votes cast are properly counted and recorded, and announced the results of the poll on the websites of the Stock Exchange and the Company in accordance with the bye-laws of the Company and the Listing Rules.

## SHAREHOLDERS' RIGHTS

# Procedures for special general meetings requisitioned by the shareholders

Shareholders holding not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company ("Requisitionists") shall have the right to require a special general meeting to be called and propose any matter to be considered at the general meeting of the Company. Provided that an annual general meeting is called for a date six weeks or less after the requisition has been deposited, the requisition though not deposited within the time required shall be deemed to have been properly deposited for the purposes thereof.

#### CONNECTED TRANSACTION

Save as disclosed below, there were no connected transactions which need to be disclosed as connected transactions pursuant to Chapter 14A of the Listing Rules during the year.

On 12 March 2019, the Company and Prize Rich Inc. ("Prize Rich") entered into an extension deed to extend the maturity date of the outstanding convertible bonds in the principal amount of HK\$166,232,000 by 5 years from 13 October 2019 to 13 October 2024, with all the terms and conditions of the outstanding convertible bonds unchanged.

As Prize Rich held 1,222,713,527 Shares, representing approximately 71.41% of the issued share capital of the Company, and was a controlling shareholder and connected person of the Company under the Listing Rules and the extension constituted a connected transaction of the Company which was subjected to announcement, circular and independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

The Independent Board Committee had been established to give recommendations to the Independent Shareholders on the proposed extension. Independent financial adviser had been appointed by the Company as to advise the Independent Board Committee and the Independent Shareholders in this regard. Related announcement and a circular were issued on 12 March 2019 and 25 April 2019 respectively. The special general meeting was convened and held on 23 May 2019 for the Independent Shareholders to approve the proposed extension.

None of the Directors, their associates or any shareholders (which to the knowledge of the Directors owns more than 5% of the Company's share capital) has an interest in the Group's five largest suppliers and customers.

#### **EMPLOYEES**

The total number of employees of the Group is approximately 197 (2018: 183). The remuneration of the employees of the Group is determined on the basis of performance and responsibility of the employees. The Group provides education allowances to the employees. The Group also provides internal training to its employees to enable them to achieve self-improvement and to enhance their job related skills. The Group also operates a share option scheme, under which qualified employees may exercise their options at an agreed price to subscribe for shares of the Company.

#### **PRE-EMPTIVE RIGHTS**

There are no provisions for pre-emptive rights under the Company's Bye-laws, or the laws of Bermuda, which would oblige the Company to offer new shares on a pro-rata basis to existing shareholders.

### 環境、社會及管治報告

### Environmental, Social and Governance Report

The Company always puts great emphasis on environmental protection, is particularly dedicated to reducing emission of greenhouse gas and promoting resource utilization efficiency and waste management, etc., and paying the highest attention to its hotel business. An environmental, social and governance ("ESG") task team has been established by Guilin Plaza Hotel to formulate relevant policies for hotel under the 5R principle (replace, reduce, reuse, recover and recycle), plan and organize the implementation of various relevant tasks and constantly put forward administrative measures, in an effort to save energy and reduce resource consumption.

本公司一直對環境保護非常重視,特別專注於減少溫室氣體排放、提高資源利用效率及廢物管理等,而本公司對酒店業務則最為關注,桂林觀光酒店成立環境、社會及管治工作小組,根據5R原則(指取代、減省、再用、回收及循環),制定酒店相關的政策,計劃、組織各項相關工作的實施,不斷提出各種管理方法,努力節約能源和減少耗用資源。

#### **EXHAUST GAS**

- Boilers and other combustion facilities have been installed flue gas purification devices that have passed the standardised test of the environmental protection administration, so as to minimize the emission of harmful gas.
- Fuel have been changed from using diesel with a lot of nitric oxide emission to clean using natural gas, so as to reduce emission of sulfur dioxide and particles.
- Exhaust gas emission has passed the test of environmental protection administration, with emission indicators has met the statutory and regulatory standards.
- All vehicles in the hotel use highly efficient fuel detergents to reduce fuel consumption and hydrocarbon emissions.
- During the year, the emissions of nitrogen oxides, cerium oxides and particulates amounted to 358.3kg, 1.83kg and 8.94kg (2018: 310.3kg, 1.6kg and 8.8kg), respectively.

#### 廢氣

- 鍋爐等燃燒設施均安裝了經環保部門檢 測達標的煙氣淨化裝置,最大限度降低 有害氣體的排放量。
- 燃料由使用排放氮氧化物較多的柴油轉為使用較清潔的天然氣,減少排放二氧化硫及微粒。
- 有關廢氣排放亦經環保部門檢測,排放 指標符合法規及規定的標準。
- 酒店所有的車輛均使用高效燃油清淨劑,以節省油耗,更使碳氫化合物的排放減少。
- 一 於年內,氮氧化物、琉氧化物及顆粒分別排放358.3公斤、1.83公斤及8.94公斤(二零一八年:310.3公斤、1.6公斤及8.8公斤)。

#### **GREENHOUSE GAS**

The greenhouse gas emitted by the Company mainly comes from electric consumption. The hotel also tries our best to reduce electric consumption and carbon footprint in the following ways.

#### **Electricity consumption**

- During the year, the hotel enhanced the solar water heating function of its solar power system, using clean and environmentally-friendly renewable energy and further reducing power consumption.
- The hotel used more new energy saving light source like LED semiconductor lamps in its lighting system during the refurbishment, which not only reduces 75% of power consumption under the same lighting effect, but also has a longer useful life and reduces the consumption of resources.
- The hotel has worked out Regulations on Energy Saving and Environmental Protection, advocating active adoption of upto-date saving techniques and management methods in the energy-saving management of the hotel, so as to practically reinforce the capacity of energy management and control, carry out energy saving and consumption reduction works, reduce operation cost and protect the environment.
- The hotel adheres to the guideline of "Full Attention and Participation by all, Constant Persistence and innovation". Therefore, we are not only dedicated to educating and training our employees and strictly enforcing relevant regulations, but also encouraging employees to put forward feasible advices to continuously improve our energy saving and control, in a bid to continuously intensify and develop energy saving of the hotel.
- During the year, the electricity comsumption and greenhouse gas emissions of the Company totalled 2,312,450 units and 1,763.35 tons (2018: 2,051,789 unit and 1,562.2 tons respectively), the increases is because the Company is under development, the consumption is proportionally increased with the expansion of the office space.

#### 溫室氣體

本公司之溫室氣體排放主要來自於電力使用, 酒店亦透過以下方法盡力減低電力耗用及碳 足跡。

#### 電耗用

- 一酒店之方針為「思想重視,全員參與,持 之以恆,不斷創新」,故致力對每員進行 教育及培訓,對有關守則嚴格執行,更 鼓勵員工提出可行的建議,以不斷豐富 能源的節約控制工作,以推動酒店節能 工作的不斷深入和發展。
- 一 於年內,公司之電耗用及溫室氣體排放 總量分別為2,312,450度及1,763.35噸 (二零一八年:2,051,789度及1,562.2 噸)增加主要由於公司業務發展,辦公室 面積增加後耗用增加。

We guide guests to correctly use the pedestal pans according to different standards for bowel movement and urination. We also encourage employees to use water frugally in daily life. We also install the intelligent inductive water-saving system in employees' bathrooms. These measures can effectively control the intensity and total amount of water consumption.

- 一酒店加強用水規範:定期進行漏水檢測和水平衡測試,水箱定期進行清洗,並有建立台賬,通過採用節水型水龍頭,安裝單獨水表計量考核,控制用水量;以及客房放置用提示卡引導客人,棉織品一日一換改為一客一換等措施,節約水資源及減少對水資源的污染。
- Strengthened water consumption regulation at the hotel: Water leakage detection and water balance testing were conducted and water tanks were cleaned on a regular basis. Ledgers were established to conduct measurement and assessment by installing separate water meters and water-saving faucets so as to exercise control over water consumption. Water-saving signs are placed in guest rooms to guide guests as a reminder, and change of cotton fabric products is made on a per guest basis instead of the previous daily basis, all aiming to reduce water consumption and minimize pollution to water resources.

- The hotel also enhanced employees' water-saving awareness to promote good habits and culture of saving water and other resources, in hope to convey the concept of resources conservation and environmental protection to guests.

- During the year, the water consumption in total of the Company totalled 34,012 m³ (2018: 33,516 m³) and is similar to last year's consumption.

#### Consumption of Other Resources and environmental impact

- The Company tries to save the use of paper by advocating "paperless office". Moreover, we reduce the use of disposable stationery, print both sides of paper, and deliver waste paper to the environmental recycling company for disposal.
- The hotel reduces resource consumption by reducing guest supplies, minimizing packages and preventing the use of disposable tableware.
- The new energy industrial park in Danzao, Nanhai is still at the preliminary stage of development. Prior to the construction of plants, the parcel of land is required to be backfilled with soil for ground surface levelling, and a total of 770,000 cubic meters (2018: 240,000 cubic meters) of soil was used during the year. In particular, the Company negotiated with the persons in charge of the neighbouring properties under construction and factories, and collected silty sandy and clayey soil excavated from the basements of the projects as part of its endeavours to reduce damage to the afforested hills and mountains, the impact on the ecological environment and the pollution and emissions caused by long-distance transportation.

The silt soil generated from the excavation of the basement of the Nanhai Danzao rental housing project is partly used as garden soil in the area, and the remaining 20,000 cubic meters are discharged in the legal landfill.

 By internally employing a method of hierarchical utilisation of food raw materials and providing catering customers with packaging and wine storage services, the hotel also minimised the consumption of food raw materials and significantly reduced the production of food waste and other wastes.

The non-hazardous wastes produced during the production and operation of the hotel are mainly household garbage and kitchen waste. The hotel has established a garbage house which meets the standards of the Star Rating and Assessment on China Tourism Hotels(《中國旅遊飯店星級劃分與評定》). All these non-hazardous wastes are collected and treated by the environment and hygiene management agencies designated by the government. Kitchen waste is processed mainly to animal feeds and composts. Therefore, it is considered as zero emission of harmless waste and the impact on the surrounding environment is minimized.

- 一 南海丹灶新能源產業園現時仍在基礎階段,在建設廠房前地塊平整場地總需要大量泥土回填以平整場地,於年內共用770,000立方米(2018:240,000立方米)。公司特別與附近樓盤及廠商洽談,收集他們工程中地下室開挖產生的场質砂粘土,以減少對山林綠化之破壞、影響生態環境及長途運輸帶來之污染及排放。

南海丹灶租賃住房項目地下室開挖而產生之淤泥質土壤,部份用作該區緣化土壤,其餘20,000立方米排放於合法消納場。

 酒店還通過建立食品原材料內部實施 分等級利用的方法、為餐飲客人提供打 包、存酒服務等,既可減少食品原材料 的耗費,又可大幅度的降低了廚餘及廢 棄物的產生。

酒店生產及營運過程中所產生的無害廢棄物主要是生活垃圾及廚餘,酒店設有達到《中國旅遊飯店星級劃分與評定》標準的垃圾房,所有這些無害廢棄物均由政府指定的環境衛生管理機構進行回收、處理,廚餘主要用作動物飼料及堆肥,因此,可視為零排放及對周邊環境的影響降到了最低的程度。

#### **HEALTH AND SAFETY**

The Company is dedicated to providing employees with a safe working environment, trying our best to prevent work from bringing any risk to the public, and paying attention to employees' health. The orientation training of the hotel employees includes the labor safety course, so as to promote employees' safety awareness and selfprotection capacity. We have worked out safe-operation procedures for each job that may bring about any risk. In addition, we carry out daily safety supervision and monthly safety check.

During the year, the company organized two firefighting evacuation drills with a total of 142 participants, 16 external safety conferences and trainings, a total of 30 participants, and the company also organized two safety knowledge trainings with a total of 123 participants. There are a total of 6 company security licenses. The safety production team made safety and fire inspections to the subsidiaries 22 times, and checked, rectified, followed up and supervised the hidden dangers.

In addition, we provide all employees with free professional health check every year.

#### 健康與安全

All new employees must receive training of industry knowledge, health and safety and job skill. Furthermore, guided by Annual Employee Training Program, we continuously offer expertise and skill training to employees every year, so that they can possess a high professional quality, maintain their competitiveness, fulfill their duties and reach the highest service standards.

In addition, we select and assign employees to pursue advanced studies at domestic well-known professional academies, with a view to bringing up professional talents with a broad vision and versed in industry operation and management.

Each employee of the hotel received 12-day training of 6 courses on average. (2018: 12-day training of 6 courses on average)

#### LABOR REGULATIONS

With regard to labor standards and human right policy, the Company strictly abides by relevant laws. The internal labor policy formulated by the Company contains a strict ban on child labor or forced labor. In each of the previous years, we smoothly passed the annual check of labor supervision by relevant government authorities.

The hotel has worked out strict purchase control measures, so as to ensure the quality and safety of all purchased raw materials. All food suppliers must provide inspection and quarantine certificates issued by the government authorities of hygiene and disease control. Materials supplied by other suppliers must also have national quality and safety (QS) certificates. The hotel has formulated and implemented a strict cargo receipt and inspection system, ensuring the quality and safety of all materials (including raw materials) purchased by us.

本核數師(以下簡稱「我們」)已審計列載於第70頁至第239頁的中國興業控股有限公司(稱為「貴公司」)及其附屬公司(稱為「貴集團」)的綜合財務報表(稱為「集團財務報表」),此綜合財務報表包括於二零一九年十二月三十一日的綜合財務狀況表與截至該日止年度的綜合損益表、綜合其他全面收益表、綜合財務報表的附註,包括主要會計政策概要。

我們認為,集團財務報表已根據香港會計師公會頒布的《香港財務報告準則》真實而中肯地反映了 貴集團於二零一九年十二月三十一日的綜合財務狀況及其截至該日止年度的綜合財務表現及綜合現金流量,並已按照香港公司條例之披露規定妥為編製。

We identified the impairment of the Group's finance lease receivables as a key audit matter due to its significance to the consolidated financial statements, and the use of judgement by the management in evaluating the recoverability of finance lease receivables.

The carrying amount of finance lease receivables is HK\$1,262,855,000 as at 31 December 2019 (2018: HK\$608,173,000), which contributed to approximately 25% to the total assets (2018: 18%). In determining the impairment for finance lease receivables, the management considers the credit worthiness, past collection history, subsequent settlement of each finance lease customer, and also relevant deposits received, value of leased assets pledged and of the guarantees. As at 31 December 2019, the Group recognised an additional impairment loss allowance of HK\$1,913,000 (2018: HK\$934,000).

As set out in Notes 5 and 24 to the consolidated financial statements, management measures expected credit loss ("ECL") for finance lease receivable by using a provision matrix. In determining the impairment of finance lease receivable, the management considers internal credit rating which reflect shared credit risk characteristics, historical past due information and lessees' creditworthiness for different groupings of finance lease receivable as parameters of the ECL models.

The Group's revenue amounted to approximately HK\$161,107,000 (2018: HK\$79,550,000), representing the gross amounts received and receivable for revenue arising on big data business, hotel operation, wellness elderly care business, sales of properties, goods sold by the Group to outside customers, less return and allowances and gross rental income, interest income generated from financial leasing, consultancy fee income provided to outsiders and others during the year. The Group adopted HKFRS 15 to consider the revenue recognition and significant judgements and estimates were required to be made by the management. The significance of the amount of revenue, the diversification of the sources of revenue, and the extensive adoption of HKFRS 15 made us identify revenue recognition as a key audit matter.

The Group's associates operate in the PRC. The Group's share of profit of associates for the year ended 31 December 2019 and the Group's interests in associates at that date are significant in the context of the Group's consolidated financial statements.

The financial information of associates is prepared in accordance with the prevailing accounting standards in the PRC which may differ in certain respects from HKFRSs.

Converting the financial information of these entities into HKFRSs for the purpose of equity accounting involves management making a number of manual adjustments some of which are complex in nature.

We identified the accounting for interests in associates in the PRC as a key audit matter because of the material impact that these entities have on the consolidated financial statements and also because of the complex nature of certain adjustments made by management which we consider increases the inherent risk of error.

- evaluating significant manual adjustments made in respect of associates to convert their financial information into HKFRSs by comparing the adjustments to underlying documentation or by re-performing the calculations on which the adjustments were based; and
- assessing whether the financial information of associates after the adjustments made by management was prepared in accordance with the Group's accounting policies.

We found management's accounting for associates after the adjustments are supportable and reasonable based on available evidence.

Interests in associates is subject to impairment assessments when there is an indication of impairment.

Management analysed the associates' cash flow and operating plan and no abnormal items were found. Management concludes that there is no impairment of interest in associate.

On 12 March 2019, the Company entered into the Extension Deed with the holder of the convertible notes issued on 13 October 2014 (the "2014 CB"), Prize Rich Inc. to extend the maturity date of the outstanding 2014 CB in the principal amount of HK\$166,232,000 by 5 years from 13 October 2019 to 13 October 2024. Since the fair value of the liability component of the 2014 CB was approximately HK\$161,667,000 on the date of redemption, the Company recorded a loss of HK\$991,000. Above transaction does not have direct impact on current cash flows.

### 1. GENERAL

The Company is incorporated in Bermuda as an exempted company with limited liability and its shares are listed on the main board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Its immediate holding company is Prize Rich Inc, which was incorporated in the British Virgin Island ("BVI") and the ultimate holding company is Guangdong Nanhai Holding Investment Co., Ltd, which was incorporated in the People's Republic of China ("the PRC"). The addresses of the registered office and principal place of business of the Company are disclosed in the "Corporate Information" section of the annual report.

During the year, the principal activities of the Group are big data business, property development and investment, financial leasing, hotel operation, investment holding and wellness elderly care business. The principal activities of the Company and its subsidiaries (the "Group") are described in Note 39.

### **Functional and presentation currency**

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Hong Kong dollars (HK\$), which is their Company's functional and the Group's presentation currency.

### 1. 簡介

### 3. SIGNIFICANT ACCOUNTING POLICIES

### Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (HKFRSs), the collective term which includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (HKASs) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (HKICPA). In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities (the "Listing Rules") on the Stock Exchange and by the Hong Kong Companies Ordinance ("CO").

#### Basis of preparation

The consolidated financial statements have been prepared on the historical cost basis except for certain properties, financial instruments that are measured at fair values and assets held for sales that are measured at fair value less costs to sell as explained in the accounting policies below. Historical cost are generally based on the fair value of the consideration given in exchange for assets.

#### Fair Value

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Share-based Payment, leasing transactions that are within the scope of HKAS 17 Leases, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

#### 編製基準

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

For financial instruments and investment properties which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date:
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities (including structured entities) controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

### Basis of consolidation (Continued)

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies to be in line with those used by other members of the Group.

All intra-group transactions, balances, income and expenses have been eliminated on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

### Changes in the Group's interests in existing subsidiaries

Changes in the Group's interests in subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests.

Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 Financial Instruments or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

Acquisition of business, other than business combination under common control, are accounted for using the acquisition method. Acquisition-related costs are generally recognised in profit or loss as incurred.

When the consideration transferred by the Group in a business combination includes a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and included as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively. Measurement period adjustments are adjustments that arise from additional information obtained during the "measurement period" (which cannot exceed one year from the acquisition date) about facts and circumstances that existed at the acquisition date.

The subsequent accounting for the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounted for within equity. Contingent consideration that is classified as an asset or a liability is remeasured to fair value at subsequent reporting dates with the corresponding gain or loss being recognised in profit or loss.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to its acquisition-date fair value and the resulting gain or loss, if any, is recognised in profit or loss or other comprehensive income, as appropriate. Amounts arising from the interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income and measured under HKFRS 9 Financial Instruments/ HKAS 39 Financial Instruments would be accounted for on the same basis as would be required if the Group had disposed directly of the previously held equity interest.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted retrospectively during the measurement period, or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed at the acquisition date that, if known, would have affected the amounts recognised at that date.

#### Acquisition of a subsidiary not constituting a business

When the Group acquires a group of assets and liabilities that do not constitute a business, the Group identifies and recognises the individual identifiable assets acquired and liabilities assumed by allocating the purchase price first to investment properties which are subsequently measured under fair value model and financial assets and liabilities at the respective fair value, the remaining balance of the purchase price is then allocated to the other identifiable assets and liabilities on the basis of their relative fair values at the date of purchase. Such a transaction does not give rise to goodwill or bargain purchase gain.

#### Investments in subsidiaries

Investments in subsidiaries are included in the Company's statement of financial position at cost less any identified impairment loss.

#### Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate.

When the Group's share of losses in an associate equals or exceeds its interest in the associate, including any other unsecured receivables, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associate.

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The Group assesses whether there is an objective evidence that the interest in an associate may be impaired. When any objective evidence exists, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 *Impairment of Assets* as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs to sell) with its carrying amount, Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

When the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition within the scope of HKFRS 9 Financial Instruments/ HKAS 39 Financial Instruments. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing the relevant interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the equity method is discontinued.

When the Group reduces its ownership interest in an associate but the Group continues to use the equity method, the Group reclassifies to profit or loss the proportion of the gain or loss that had previously been recognised in other comprehensive income relating to that reduction in ownership interest if that gain or loss would be reclassified to profit or loss on the disposal of the related assets or liabilities.

When a group entity transacts with an associate of the Group (such as a sale or contribution of assets), profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of the interests in the associate that are not related to the Group.

### Impairment of goodwill

For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash generating units ("CGUs"), or groups of CGUs, that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the entity at which the goodwill is monitored for internal management purposes. Goodwill is monitored at the operating segment level.

Goodwill impairment reviews are undertaken annually or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of goodwill is compared to the recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

To the extent that any decrease has previously been recognised in profit or loss, a revaluation increase is credited to profit or loss with the remaining part of the increase dealt with in other comprehensive income. A decrease in net carrying amount of hotel properties arising on revaluations or impairment testing is recognised in other comprehensive income to the extent of the revaluation surplus in the properties revaluation reserve relating to the same asset and the remaining decrease is recognised in profit or loss.

Construction in progress represents property, plant and equipment in the course of construction for production or for own use purposes. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

The gain or loss arising on the disposal or retirement of an asset is determined as the difference between the sale proceeds and the carrying amount of the asset and is recognised in the profit and loss.

Assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. The Group performs impairment assessment under expected credit loss ("ECL") model on financial assets (including trade receivables and finance lease receivables) which are subject to impairment under HKFRS 9 *Financial Instruments*. Lifetime ECL represents the ECL that will result from all possible default events over the expected life of the relevant instrument. #### **Provisions**

#### **Government grants**

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to income is presented in gross under "other income" in the consolidated statement of profit or loss and other comprehensive income.

#### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years, and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted at the end of each reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

Effective 1 January 2019, any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### Finance leases

Leases that transfer substantially all the rewards and risks of ownership of assets to the Group, other than legal title, are accounted for as finance leases. In the application of the Group's accounting policies, which are described in Note 3, management is required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### Critical judgements in applying accounting policies

The following are the critical judgements, apart from those involving estimations, that management has made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in the consolidated financial statements.

#### Deferred taxation on investment properties

For the purpose of measuring deferred tax liabilities or deferred tax assets arising from investment properties that are measured using the fair value model, the Directors have reviewed that Group's investment properties portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in measuring the Group's deferred taxation on investment properties, the Directors have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is not rebutted. Moreover, the fair value of the Group's investment properties is lower than acquisition cost. As a result, the Group has not recognised any deferred taxes on change in fair value of investment properties as the Group is not subject to any incomes taxes on disposal of its investment properties.

#### Deferred taxation on hotel properties

By comparing the initial cost and the revaluated value of PRC hotel properties of the Group, the Directors considered that no capital gain may generate and does not constitute a timing difference and not expect to settle the carrying amount of the tax liabilities. Therefore, deferred tax has not been recognised in respect of the valuation surplus relating to Hotel properties.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

## Estimated the useful lives of property, plant and equipment

The Group determines the estimated useful lives and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. Management will revise the depreciation charge where useful lives are different to previously estimated, or will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold.

## Estimated impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets and are reviewed for impairment when events or changes in circumstances indicate that the carrying amount of the assets exceeds its recoverable amount. The recoverable amount is determined with reference to the higher of fair value of the property, plant and equipment and right-of-use assets less costs to sell or the value-in-use calculations. An impairment loss is measured as the difference between the asset's carrying amount and the recoverable amount. Where the recoverable amount is less than expected, a material impairment loss may arise. As at 31 December 2019 the Group reported no impairment loss for certain property, plant and equipment and right-of use assets (2018: Nil).

## Estimation of fair value of the Group's other assets and liabilities

Some of the Group's assets and liabilities are measured at fair value for financial reporting purposes.

In estimating the fair value of an asset or a liability, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Group engages third party qualified valuers to perform the valuation. The qualified external valuers establish the appropriate valuation techniques and inputs to the model. The Financial Controller reports the qualified external valuers' findings to the board of Directors of the Company every quarter to explain the cause of fluctuations in the fair value of the assets and liabilities.

The Group uses valuation techniques that include inputs that are not based on observable market data to estimate the fair value of certain types of financial instruments. Note 5, 16 and 17 provide detailed information about the valuation techniques, inputs and key assumptions used in the determination of the fair value of various assets and liabilities.

## Estimation of fair value of the Group's investment properties and hotel properties

The Group's properties were revalued as at 31 December 2019 based on the appraised market value by independent professional valuers. Such valuations were based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the estimate of fair value, the Group considers information from current prices in an active market for similar properties in the same location and condition and uses assumptions that are mainly based on market conditions existing at the end of each reporting period.

## Estimated impairment of trade receivables and finance lease receivables

The management of the Group estimates the amount of impairment loss allowance for trade receivables and finance lease receivables by assessing the ECLs, which requires the use of estimates and judgements. Assessing the ECLs requires to use provision matrix based on the Group's historical credit loss experience, and review general conditions, internal credit ratings and an assessment of both the current conditions at the reporting date as well as the forecast of future conditions. The impairment loss allowance of ECLs is sensitive to changes in estimates.

The information about the ECLs and the Group's impairment loss allowance regarding trade receivables and finance lease receivables are disclosed in Note 5, 24 and 25.

#### Leases - Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, therefore, it uses its incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group "would have to pay", which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease (for example, when leases are not in the subsidiary's functional currency). The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.

The Group's businesses are principally conducted in the PRC and Hong Kong and accordingly are subject to special considerations and several risks.

#### Foreign Exchange Exposure

The Group's operating income and costs are denominated in RMB. In the business operation of the Group, foreign exchange fluctuation of income and costs would be mutually offset. However, as the Hong Kong-based Group has invested substantial borrowings into domestic wholly-owned subsidiaries in the Mainland whilst owning substantial RMB denominated monetary assets, an exchange gain or loss will be recorded due to the appreciation or depreciation of RMB. The Board expected that RMB will be immensely affected by any change in the Sino-US trade war in the short term, therefore the trend of RMB is unforeseeable in the short term. In the long run, RMB's exchange rate will not fluctuate drastically and will not bring material adverse foreign exchange risk on the Group. Therefore, the Group currently does not have any specific foreign exchange risk hedging need for this matter.

#### Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for equity holders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital. In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to equity holders, return capital to equity holders, issue new shares or sell assets to reduce debt.

The capital structure of the Group consists of debt (which includes bank loans and convertible notes) and equity attributable to owners of the Company (comprising issued share capital, share premium, reserves and retained earnings).

The Directors of the Company review the capital structure on a semi-annual basis. As part of this review, the Directors consider the cost of capital and will balance its overall capital structure through issue of new shares as well as the issue of new debt or the redemption of existing debt.

The Group's cash flow interest rate risk mainly arises from the Group's RMB denominated borrowings. It is the Group's policy to keep its borrowings at floating rate of interest so as to minimise the fair value interest rate risk.

#### Interest rate sensitivity analysis

The sensitivity analysis below have been determined based on the exposure to interest rates for borrowings at the end of the reporting period. The analysis is prepared assuming the borrowings outstanding at the end of the reporting period were outstanding for the whole year. A 50 basis points (2018: 50 basis points) increase or decrease in interest rate is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 50 basis points (2018: 50 basis points) higher/lower and all other variables were held constant, the Group's post-tax profit for the year ended 31 December 2019 would decrease/increase by HK\$5,719,000 (2018: HK\$3,187,000). This is mainly attributable to the Group's exposure to interest rates on its variable rate borrowings.

#### Liquidity risk management

Ultimate responsibility for liquidity risk management rest with the board of Directors. In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

#### Credit risk

As at 31 December 2019 and 2018, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties is arising from the carrying amount of respective financial assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its city ledger from hotel, which belongs to trade receivables and finance lease receivables. Credit risk on other receivables is limited because no historical default record has been made during the year and the Directors expect that the general economic conditions will not significantly changed for the 12 months after the reporting date.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determining of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts (please refer to Notes 24 and 25). In addition, the management of the Group reviews the recoverable amount of each individual receivable at the end of reporting period to ensure that adequate impairment loss is made for irrecoverable amounts. In this regard, the Directors of the Company consider that the Group's credit risk is significantly reduced.

The Group applied the simplified approach to measure ECL on its trade receivables from hotel operation and finance lease receivables. Under the simplified approach, the Group measures the loss allowance at an amount equal to lifetime ECL.

To measure the ECL on trade receivables from hotel operation, based on forward-looking economic information through the use of industry trend and experienced credit judgement as well as past experience including historical credit loss experience and current expectations, the Group has collectively used a provision matrix with 5% ECL rate on total carrying amount of trade receivables from hotel operation, without distinguishing different ECL rates based on different customer segments nor past due status.

To measure the ECL on finance lease receivables, finance lease receivables have been grouped based on shared credit risk characteristics. The Group has collectively applied another provision matrix with two different ECL rates, which in other words classified the credit risk regarding finance lease receivables into 2 grades. ECL rates of the Group's finance lease receivables, which represent internal credit risk ratings, are based on qualitative (such as lessee's operating conditions, financial positions, usage of finance lease assets, etc.) and quantitative factors (mainly include past due information of the finance lease receivables). The following table provides information about the exposure to credit risk of finance lease receivables and the provision matrix showing the ECL as at 31 December 2019 and 2018.

## 13. RETIREMENT BENEFIT SCHEME

The Group contributes to a defined contribution retirement scheme which is available to Hong Kong permanent employees under the Occupational Retirement Scheme Ordinance. This retirement scheme is administered by independent trustees with their assets held separately from those of the Group. Contributions under the staff retirement scheme for each year are based on a percentage of the eligible employees' salaries and are charged to the consolidated statement of profit or loss and other comprehensive income as incurred. The total contribution to the scheme amounted to HK\$45,738 (2018: HK\$41,651) for the year and has been charged to the consolidated statement of profit or loss and other comprehensive income. Forfeited employer contributions in respect of former employees from the staff retirement scheme before vesting period may be used by the Group to reduce its ongoing employer contributions. There is no forfeited contribution utilised during the year.

At the end of the reporting period, there is no balance of forfeited contributions available to reduce the contribution payable in the future years.

Since the introduction of the Mandatory Provident Fund ("MPF") Scheme in Hong Kong, the Group has also participated in an approved MPF Scheme with Bank Consortium Trust Company Limited effective 1 December 2001 to provide an MPF Scheme to all employees. The contributions borne by the Group are calculated at 5% of the salaries and wages (monthly contribution is limited at 5% of HK\$30,000 for each eligible employee) as calculated under the MPF legislation. During the year under review, the total amount contributed by the Group to the MPF Scheme and charged to the consolidated statement of profit or loss and other comprehensive income amounted to HK\$79,989 (2018: HK\$76,999).

The employees employed in the PRC subsidiaries are members of the state-managed retirement benefits schemes operated by the PRC government. The PRC subsidiaries are required to contribute a certain percentage of their payroll to the retirement benefits schemes to fund the benefits. The only obligation of the Group with respect to the retirement benefits schemes is to make the required contributions under the schemes.

#### 14. DIVIDENDS

The Directors do not recommend the payment of any dividend for the year ended 31 December 2019 (2018: Nil).

All of the Group's property interests held to earn rentals or for capital appreciation purposes are measured using the fair value model and are classified and accounted for as investment properties.

On 31 May 2019, the Group acquired the entire interest in a commercial plaza located in Nanhai District, Foshan City, PRC with a consideration of HK\$200,145,000, which was subsequently revalued by the Group as at 31 December 2019.

The carrying amount of investment properties amounting to HK\$293,915,000 (2018: HK\$210,706,000) have been pledged to secure general banking facilities and mortgage loan to the Group.

Investment properties were revalued at their open market value at 31 December 2019 by Associated Surveyors & Auctioneers Ltd., an independent firm of professional valuer, on an open market value basis. The valuation gave rise to a revaluation surplus of HK\$4,618,000 (2018: surplus of HK\$8,945,000), which has been recognised in profit or loss.

# Associated Surveyors & Auctioneers Ltd is a member of the Institute of Valuers of Hong Kong, and has appropriate qualifications and recent experiences in the valuation of similar properties in the relevant locations. The valuation, which conforms to International Valuation Standards, was arrived at by reference to market evidence of transaction prices for similar properties.

There has been no change from the valuation technique used in the prior year. In estimating the fair value of the properties, the highest and best use of the properties is their current use.

The Group's investment properties were classified under level 3 of the fair value hierarchy. There were no transfers into or out of Level 3 during the year.

The following table gives information about how the fair values of the investment properties are determined (in particular, the valuation techniques and inputs used), as well as the fair value hierarchy into which the fair value measurements are categorised (Level 3) based on the degree to which the inputs to the fair value measurements is observable.

#### Fair value measurement of the Group's buildings

The Group's hotel properties situated in the PRC were valued on 31 December 2019 and 31 December 2018 by Associated Surveyors & Auctioneers Ltd., an independent valuer not related to the Group.

The fair value of the buildings were determined based on the market comparable approach that reflects recent transaction prices for similar properties, adjusted for differences in the nature, location and condition of the buildings under review. There has been no change to the valuation technique during the year.

The Group's hotel properties were classified under level 3 in the fair value hierarchy. There were no transfer into or out of level 3 during the year.

In estimating the fair value of the properties, the highest and best use of the properties is their current use.

If hotel properties had not been revalued, they would have been included in these financial statements at historical cost less accumulated depreciation of HK\$61,662,000 (2018: HK\$64,248,000).

(a) Referring the circular dated on 31 October 2019, the Group entered into a disposal agreement with Foshan City Nanhai Financial Hi-Tech Zone Investment Holdings Co., Ltd.\* ("Nanhai Financial Hi-Tech Holdings"), pursuant to which Nanhai Financial Hi-Tech Holdings has conditionally agreed to purchase 25% equity interest in Guangdong Financial Leasing Co., Ltd.\* ("Guangdong Financial Leasing") at a cash consideration of RMB52,720,000 (equivalent to approximately HK\$58,971,000) and the Group agreed to continue to lend to the purchaser in the form of the outstanding shareholder's loan in the amount of approximately RMB157,120,000 (equivalent to approximately HK\$172,046,400) following the completion of this transaction.

Since the transaction would not be completed for the year ended 31 December 2019, the Group decided to reclassify the interest in Guangdong Financial Leasing as asset held for sale on 31 October 2019. Details of asset classified as held for sale for the year ended 31 December 2019 are set out in Note 19. For the ten months ended 31 October 2019, Guangdong Financial Leasing recorded operating profit of approximately HK\$26,250,000 and total comprehensive income of approximately HK\$9,797,000. From the date on which the interest in Guangdong Financial Leasing was reclassified as asset held for sale, the investment in Guangdong Financial Leasing was discontinued to be accounted for using the equity method.

- (b) On 18 March 2019, the Group entered into a capital increment agreement with another existing investor in which the registered capital of Nanhai Changhai Power Company Limited\* ("Nanhai Changhai") would be increased from USD31,132,460 to USD32,235,446. The transaction was completed on 11 October 2019. The Group did not subscribe for additional shareholding and accordingly, the equity interest held by the Group in Nanhai Changhai decreased from 32.636% to 31.875% after completion of the transaction. Deemed disposal of an associate amounted to HK\$3,993,000 is recognised in the Group's interest in Nanhai Changhai as at 31 December 2019.
- (c) On 25 March 2019, Foshan City Nanhai Canmanage Investment Holding Limited\* ("Nanhai Canmanage"), a subsidiary of the Company, entered into the Capital Injection Agreement with Guangdong Nanhai Chemical Factory Co., Ltd.\* ("Nanhai Chemical"), Foshan City Nanhai District Lianhua Asset Operation & Management Co., Ltd.\* ("Nanhai Lianhua") and Guangdong Tiannuo Civil Co., Limited\* ("Tiannuo") in relation to the Capital Injection on the basis of their respective shareholding proportion in Tiannuo. Upon completion of the entire Capital Injection, the percentage shareholding interest of Nanhai Canmanage, Nanhai Lianhua and Nanhai Chemical in Tiannuo will remain unchanged at 49%, 2% and 49% respectively.

On 6 December 2017, the Group obtained a loan facility from a bank of approximately USD110,090,000 for which a controlling shareholder has provided the necessary corporate guarantee. As at 31 December 2019, the Group has drawdown an amount of USD100,000,000 (equivalent to approximately HK\$778,900,000) (2018: USD100,000,000, equivalent to approximately HK\$783,038,000).

In March 2018, the Group obtained two two-year unsecured loans amounting to RMB70,000,000 (equivalent to approximately HK\$78,300,000) in total from two independent third parties, at a floating interest rate plus a premium calculated at 10% above the prevailing RMB benchmark rate published by The People's Bank of China. On 26 February 2019, the Group entered into the Supplemental Loan Agreements with these two parties respectively, in which the loan repayment periods for these two loans were extended by 2 years to March 2022. Interest rates and any other terms and conditions of the loans remained unchanged.

On 16 April 2018, the Group obtained a loan facility of HK\$40,000,000 (loan facility 1) from Hang Seng Bank. Since the facility limit would be reduced by 10% of the facility amount each year, it became HK\$36,000,000 during the year. On 11 April 2019, the Group obtained another loan facility of HK\$52,700,000 (loan facility 2) from Hang Seng Bank. These two loan facilities were secured by the Group's property which is situated at Unit 01, 14 and 15 on 5th Floor, Wing On Plaza, No. 62 Mody Road, Kowloon, Hong Kong. As at 31 December 2019, the Group has drawdown an amount of HK\$78,350,000 in aggregate.

Taking into account the Group's financial position and assets pledged for the loans, the Directors did not believe that it was probable that the lenders would exercise the discretionary rights to demand immediate payments. Unless previously redeemed, converted or purchased and cancelled, the 2014 CB will be redeemed on 13 October 2019. ("Prize Rich") to extend the maturity date of the outstanding 2014 CB in the principal amount of HK\$166,232,000 by 5 years from 13 October 2019 to 13 October 2024 (the "Extended CB Maturity Date"), with all the terms and conditions of the outstanding 2014 CB unchanged. On 23 May 2019, after passing the ordinary resolution to approve the extension deed by the shareholders at the special general meeting, the extension deed became effective. The 2014 CB was redeemed and new convertible notes with the same terms but the Extended CB Maturity Date (the "2019 CB") was issued. Since the fair value of the liability component of the 2014 CB was approximately HK\$161,667,000 on the date of redemption, the Company recorded a loss of HK\$991.000.

The 2019 CB in the principal amount of HK\$166,232,000 (of which its fair value at the issuance date is approximately HK\$109,616,000) bears coupon rate at 2% per annum and is convertible into shares of the Company at a conversion price of HK\$0.76 per share at any time following the issue date up to the maturity date. At any time prior to the maturity date of the 2019 CB, the Company is entitled to redeem in whole or in part of the 2019 CB. Unless previously redeemed, converted or purchased and cancelled, the 2019 CB will be redeemed on 13 October 2024. The 2019 CB carries interest at a rate of 2% per annum, which is payable annually in arrears or upon the conversion or redemption of the notes.

The convertible notes contain two components, liability, and equity components. The equity component is presented in equity under heading "convertible note equity reserve". The values of the liability component and the equity conversion component were determined at the issuance of the notes.

At the end of the reporting period, the Group has unused tax losses of HK\$13,288,000 (2018: HK\$26,732,000) available for offset against future profits. No deferred tax asset has been recognised in respect of that tax losses due to the unpredictability of future profit streams.

Pursuant to the PRC Corporate Income Tax Law dependent upon the nationality and domicile of the foreign investors, a 5% to 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement has become effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rates range from 5% to 10%.

#### 43. NATURE AND PURPOSE OF RESERVES

#### (i) Share premium

Share premium represents premium arising from the issue of shares at a price in excess of their par value per share and is not attributable but may be applied in paying up unissued shares of the Company to be issued to the shareholders of the Company as fully paid bonus shares or in providing for the premiums payable on repurchases of shares

#### (ii) Statutory reserves

Statutory reserve represents general reserve and enterprise expansion fund which are set up by subsidiaries established and operated in the People's Republic of China ("PRC") by way of appropriation from the profit after taxation in accordance with the relevant laws and regulations in the PRC. The rate of appropriation of the general reserve and enterprise expansion fund is subject to the decision of the board of Directors of the PRC subsidiaries, but the minimum appropriation rate for the general reserve is 10% of the profit after taxation for the each year, until when the accumulated balance reaches 50% of the total registered capital of the subsidiary. Pursuant to the relevant laws and regulations of the PRC, if approvals are obtained from the relevant government authorities, the general reserve can be used in setting off accumulated losses or to increase the capital, and the enterprise expansion fund can be used to increase the capital.

#### (iii) Hotel properties revaluation reserve

Hotel properties are revalued annually based on independent professional valuations on an open market value basis. Changes in the values of hotel properties are dealt with as movement in the hotel properties revaluation reserve. If the reserve is insufficient to cover a revaluation deficit, the excess of the deficit is changed to the profit and loss account.

#### (iv) Exchange reserve

The exchange reserve comprises all foreign exchange differences arising from the translation of the financial statements of the foreign subsidiaries of the Group whose reporting currency is not Hong Kong dollars. The reserve is dealt with in accordance with the accounting policies of foreign currencies set out in Note 3 to the consolidated financial statements.

#### (v) Convertible note equity reserve

Convertible note equity reserve represents the value of the unexercised equity component of convertible bond issued by the Company recognised in accordance with the accounting policy of Convertible note set out in Note 3 to the consolidation financial statements.

#### (vi) Capital reserve

Capital reserve represented additional contributions made by the shareholders of the Company's subsidiaries and, in case of an acquisition of an additional non-controlling interest of a subsidiary, the difference between the cost of acquisition and the non-controlling interest acquired.

#### (vii) Other reserve

Other reserve comprises of gain on partial disposal of interest in a non-wholly owned subsidiary. Details was set out in Note 37(b).
